## Product description: BIOPRO 20L – Light-low fat moderately toasted soft soybean powder

This type of flour is produced from healthy, genetically nonmodified soybeans, which are crushed and dehulled. Through special heat treatment and toasting at desired temperatures, all anti-nutritional factors are drained, which increases the utilization of proteins. The oil is isolated by pressing process in a natural way, without extraction, so there is no danger from the presence of residual solvent. The product is significant because of the high nutritional and biological value.
